# **Revisions to the Guidelines Offense Table**

The Maryland State Commission on Criminal Sentencing Policy (MSCCSP) has revised the Guidelines Offense Table to reflect:

- (1) classification of new offenses passed during the 2023 Legislative Session;
- (2) classification of amended offenses passed during the 2023 Legislative Session;
- (3) classification of three previously unclassified offenses;
- (4) revised seriousness categories for subsequent drug offenses with a 40-year maximum penalty; and
- (5) minor edits to the table.

These changes were adopted in the Code of Maryland Regulations (COMAR) effective November 13, 2023. A print friendly version of the updated <u>Guidelines Offense Table</u> (Appendix A of the <u>Maryland Sentencing Guidelines Manual</u>) is available on the MSCCSP website. This file is searchable by key word, CJIS Code, Source, etc. Please discard any prior versions of the Guidelines Offense Table, as information in prior versions may no longer be accurate.

These offenses were added to the Guidelines Offense Table since they are expected to be prosecuted in the circuit courts.

Since the guidelines apply only to criminal offenses, this offense was removed from the Guidelines Offense Table. *Perverted sexual practice* occurring on/after October 1, 2023, is not a guidelines offense.

#### **Minor Edits**

Minor edits to the Guidelines Offense Table include replacing all instances of "inmate" with "incarcerated individual." This was done in response to Senate Bill 293 (2023) which alters the term "inmate" to be "incarcerated individual" in the Annotated Code of Maryland. Six offenses in the Guidelines Offense Table were impacted by this change.
